**Background:** Cook County and participating municipalities in the county developed a hazard mitigation plan to reduce risk from all hazards by identifying resources, information, and strategies for risk reduction. The federal Disaster Mitigation Act of 2000 requires state and local governments to develop hazard mitigation plans as a condition for federal disaster grant assistance. To prepare the plan, the participating partners organized resources, assessed risks from natural hazards within the county, developed planning goals and objectives, reviewed mitigation alternatives, and developed an action plan to address probable impacts from natural hazards. By completing this process, these jurisdictions maintained compliance with the Disaster Mitigation Act, achieving eligibility for mitigation grant funding opportunities afforded under the Robert T. **Summary Overview of the Plan's Progress:** The performance period for the Hazard Mitigation Plan became effective on September 26, 2014, with the final approval of the plan by FEMA. **Purpose:** The purpose of this report is to provide an annual update on the implementation of the action plan identified in the Cook County Multi-Jurisdictional Hazard Mitigation Plan.
